

**PhillipMart Announces Pre-IPO Share Price of
 Zhejiang Tengy Environmental Technology Co., Ltd (Stock code: 01527)**

(Hong Kong – 9 Oct 2015) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of Zhejiang Tengy Environmental Technology Co., Ltd (“Tengy Env”; stock code: 01527) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Tengy Env on PhillipMart were HK\$11.90 and HK\$11.52. The price closed at HK\$11.56 per share, 6.06% higher than its offer price of HK\$10.90. The price opened at HK\$11.90, with the most actively traded price of HK\$11.60 per share, and a turnover of 33,200 shares. The total trading volume reached 134,000 shares with **total turnover of HK\$1,552,272.00**. The final price of Tengy Env, to debut trading on 12 Oct and it has been fixed at HK\$10.90 per share.
