

PhillipMart Announces Pre-IPO Share Price of Lanzhou Zhuangyuan Pasture Co., Ltd. (Stock code: 01533)

(Hong Kong – 14 Oct 2015) Phillip Securities (HK) Ltd. ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of Lanzhou Zhuangyuan Pasture Co., Ltd. ("Zhuangyuan Pasture"; stock code: 01533) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Zhuangyuan Pasture on PhillipMart were HK\$5.53 and HK\$5.42. The price closed at HK\$5.53 per share,4.34% higher than its offer price of HK\$5.30. The price opened at HK\$5.49, with the most actively traded price of HK\$5.43 per share, and a turnover of 100,000shares. The total trading volume reached 360,500shares with **total turnover of HK\$1,970,390.00**. The final price of Zhuangyuan Pasture, to debut trading tomorrow has been fixed at HK\$5.30 per share.
