PhillipMart Announces Pre-IPO Share Price of China Partytime Culture Holdings Limited (Stock code: 01532)

(Hong Kong – 15 Oct 2015) Phillip Securities (HK) Ltd. ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of China Partytime Culture Holdings Limited ("China Partytime"; stock code: 01532) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for China Partytime on PhillipMart were HK\$1.20 and HK\$0.88. The price closed at HK\$0.94 per share,6% lower than its offer price of HK\$\$1.00. The price opened at HK\$1.10, with the most actively traded price of HK\$0.91 per share, and a turnover of 2,439,000shares. The total trading volume reached 14,421,000shares with total turnover of HK\$14,067,390.00. The final price of China Partytime, to debut trading tomorrow has been fixed at HK\$1.00per share.
