

PhillipMart Announces Pre-IPO Share Price of Jiyi Household International Holdings Limited (Stock code: 01495)

(Hong Kong – 5 Nov 2015) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of Jiyi Household International Holdings Limited ("Jiyi Household"; stock code: 01495) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Jiyi Household on PhillipMart were HK\$1.48 and HK\$1.32. The price closed at HK\$1.40 per share,9.38% higher than its offer price of HK\$\$1.28. The price opened at HK\$1.40, with the most actively traded price of HK\$1.38 per share, and a turnover of 362,000shares. The total trading volume reached 1,446,000shares with **total turnover of HK\$2,014,380.00**. The final price of Jiyi Household, to debut trading tomorrow has been fixed at HK\$1.28 per share.
