

## PhillipMart Announces Pre-IPO Share Price of China International Capital Corporation Limited (Stock code: 03908)

(Hong Kong – 6 Nov 2015) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of China International Capital Corporation Limited ("CICC"; stock code: 03908) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for CICC on PhillipMart were HK\$11.14 and HK\$10.80. The price closed at HK\$11.14 per share,8.37% higher than its offer price of HK\$\$10.28. The price opened at HK\$10.90, with the most actively traded price of HK\$10.90 per share, and a turnover of 2,044,800shares. The total trading volume reached 6,108,400shares with **total turnover of HK\$66,842,008.00**. The final price of CICC, to debut trading on 9 Nov and has been fixed at HK\$10.28 per share.
