## PhillipMart Announces Pre-IPO Share Price of CHINNEY KIN WING HOLDINGS LIMITED (Stock code: 01556)

(Hong Kong – 10Nov 2015) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **Chinney Kin Wing Holdings Limited** ("**Chinney Kin Wing**"; stock code: 01556) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **Chinney Kin Wing** on PhillipMart were HK\$0.65 and HK\$0.58. The price closed at HK\$0.6 per share, 1.69% higher than its offer price of HK\$\$0.59. The price opened at HK\$0.65, with the most actively traded price of HK\$0.59 per share, and a turnover of 6,490,000shares. The total trading volume reached 16,910,000shares with **total turnover of HK\$10,144,500.00**. The final price of **Chinney Kin Wing**, to debut trading tomorrow has been fixed at HK\$0.59per share.
