

PhillipMart Announces Pre-IPO Share Price of Denox Environmental & Technology Holdings Limited (Stock code: 01452)

(Hong Kong – 11 Nov 2015) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of Denox Environmental & Technology Holdings Limited (“Denox Env”; stock code: 01452) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Denox Env on PhillipMart were HK\$2.12 and HK\$2.06. The price closed at HK\$2.12 per share, 0.95% higher than its offer price of HK\$2.10. The price opened at HK\$2.06, with the most actively traded price of HK\$2.10 per share, and a turnover of 44,000shares. The total trading volume reached 83,000shares with **total turnover of HK\$174,560.00**. The final price of Denox Env, to debut trading tomorrow has been fixed at HK\$2.10 per share.
