

PhillipMart Announces Pre-IPO Share Price of Wenzhou Kangning Hospital Co., Ltd. (Stock code: 02120)

(Hong Kong – 19 Nov 2015) Phillip Securities (HK) Ltd. ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of Wenzhou Kangning Hospital Co., Ltd. ("Kangning Hospital"; stock code: 02120) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Kangning Hospital on PhillipMart were HK\$42.70 and HK\$40.00. The price closed at HK\$42.55 per share,9.95% higher than its offer price of HK\$\$38.70. The price opened at HK\$40.00, with the most actively traded price of HK\$40.80 per share, and a turnover of 132,300 shares. The total trading volume reached 590,900shares with **total turnover of HK\$24,358,415.00**. The final price of Kangning Hospital, to debut trading tomorrow has been fixed at HK\$38.70 per share.
