

**PhillipMart Announces Pre-IPO Share Price of
 Dali Foods Group Company Limited (Stock code: 03799)**

(Hong Kong – 19 Nov 2015) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of Dali Foods Group Company Limited (“Dali Foods”; stock code: 03799) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Dali Food on PhillipMart were HK\$5.20 and HK\$4.96. The price closed at HK\$5.20 per share, 0.95% lower than its offer price of HK\$5.25. The price opened at HK\$5.20, with the most actively traded price of HK\$5.10 per share, and a turnover of 742,500 shares. The total trading volume reached 2,365,000 shares with **total turnover of HK\$11,986,725.00**. The final price of Dali Food, to debut trading tomorrow has been fixed at HK\$5.25 per share.
