

PhillipMart Announces Pre-IPO Share Price of Zhong Ao Home Group Limited (Stock code: 01538)

(Hong Kong – 24 Nov 2015) Phillip Securities (HK) Ltd. ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of Zhong Ao Home Group Limited ("Zhong Ao Home"; stock code: 01538) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Zhong Ao Home on PhillipMart were HK\$2.15 and HK\$1.95. The price closed at HK\$2.11 per share,12.23% higher than its offer price of HK\$\$1.88. The price opened at HK\$1.95, with the most actively traded price of HK\$1.98 per share, and a turnover of 296,000shares. The total trading volume reached 1,852,000shares with **total turnover of HK\$3,838,480.00**. The final price of Zhong Ao Home, to debut trading tomorrow has been fixed at HK\$1.88 per share.
