

PhillipMart Announces Pre-IPO Share Price of **UMP HEALTHCARE HOLDINGS LIMITED (Stock code: 00722)**

(Hong Kong – 26 Nov 2015) Phillip Securities (HK) Ltd. ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of UMP HEALTHCARE HOLDINGS LIMITED ("UMP HEALTHCARE"; stock code: 00722) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for UMP HEALTHCARE on PhillipMart were HK\$2.06 and HK\$2.00. The price closed at HK\$2.03 per share,1.46% lower than its offer price of HK\$\$2.06. The price opened at HK\$2.00, with the most actively traded price of HK\$2.06 per share, and a turnover of 254,000shares. The total trading volume reached 954,000shares with total turnover of HK\$1,1945,000. The final price of UMP HEALTHCARE, to debut trading tomorrow has been fixed at HK\$2.06 per share.
