

## PhillipMart Announces Pre-IPO Share Price of Manfield Chemical Holdings Linited (Stock code: 01561)

(Hong Kong – 30 Nov 2015) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of Manfield Chemical Holdings Linited ("Manfield Chemical"; stock code: 01561) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Manfield Chemical on PhillipMart were HK\$1.04 and HK\$0.91. The price closed at HK\$1.04 per share,4% higher than its offer price of HK\$\$1.00. The price opened at HK\$1.03, with the most actively traded price of HK\$1.00 per share, and a turnover of 1,200,000shares. The total trading volume reached 4,136,000shares with **total turnover of HK\$4,116,600.00**. The final price of Manfield Chemical, to debut trading tomorrow has been fixed at HK\$1.00 per share.
