

PhillipMart Announces Pre-IPO Share Price of Bank of Jinzhou Co., Ltd (Stock code: 00416)

(Hong Kong – 4 Dec 2015) Phillip Securities (HK) Ltd. ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of Bank of Jinzhou Co., Ltd ("Bank of Jinzhou"; stock code: 00416) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Bank of Jinzhou on PhillipMart were HK\$4.60 and HK\$4.49. The price closed at HK\$4.56 per share,2.15% lower than its offer price of HK\$\$4.66. The price opened at HK\$4.56, with the most actively traded price of HK\$4.56 per share, and a turnover of 23,000shares. The total trading volume reached 40,000shares with **total turnover of HK\$182,110.00**. The final price of Bank of Jinzhou, to debut trading on 7Dec and it has been fixed at HK\$4.66 per share.
