

## PhillipMart Announces Pre-IPO Share Price of FSE ENGINEERING HOLDINGS LIMITED (Stock code: 00331)

(Hong Kong – 9 Dec 2015) Phillip Securities (HK) Ltd. ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of FSE ENGINEERING HOLDINGS LIMITED ("FSE ENGINEERING"; stock code: 00331) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for FSE ENGINEERING on PhillipMart were HK\$2.40 and HK\$2.10. The price closed at HK\$2.17 per share,21.09% lower than its offer price of HK\$2.75. The price opened at HK\$2.40, with the most actively traded price of HK\$2.11 per share, and a turnover of 400,000 shares. The total trading volume reached 4,417,000 shares with **total turnover of HK\$9,687,930.00**. The final price of FSE ENGINEERING, to debut trading tomorrow has been fixed at HK\$2.75 per share.
