## **PhillipMart Announces Pre-IPO Share Price of CLEAR LIFT HOLDINGS LIMITED (Stock code: 01341)**

(Hong Kong – 9 Dec 2015) Phillip Securities (HK) Ltd. ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of CLEAR LIFT HOLDINGS LIMITED ("CLEAR LIFT"; stock code: 001341) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for CLEAR LIFT on PhillipMart were HK\$0.520 and HK\$0.485. The price closed at HK\$0.50 per share,4.167% higher than its offer price of HK\$0.48. The price opened at HK\$0.495, with the most actively traded price of HK\$0.50 per share, and a turnover of 8,320,000 shares. The total trading volume reached 14,840,000shares with total turnover of HK\$7,426,440.00. The final price of CLEAR LIFT, to debut trading tomorrow has been fixed at HK\$0.48 per share.

In view of customers demand, Phillip Securities announce that the trading hours of PhillipMart has be changed from 4:30p.m. - 6:00p.m. to 4:15p.m.-6:30p.m. effective from Thursday, 29 March 2012.
