

PhillipMart Announces Pre-IPO Share Price of SFK CONSTRUCTION HOLDINGS LIMITED (Stock code: 01447)

(Hong Kong – 9 Dec 2015) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of SFK CONSTRUCTION HOLDINGS LIMITED ("SFK"; stock code: 01447) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for SFK on PhillipMart were HK\$1.35 and HK\$1.28. The price closed at HK\$1.30 per share,3.7% lower than its offer price of HK\$1.35. The price opened at HK\$1.30, with the most actively traded price of HK\$1.30 per share, and a turnover of 344,000shares. The total trading volume reached 598,000shares with **total turnover of HK\$782,700.00**. The final price of SFK, to debut trading tomorrow has been fixed at HK\$1.35 per share.
