

**PhillipMart Announces Pre-IPO Share Price of  
 CHINA ENERGY ENGINEERING CORPORATION LIMITED (Stock code: 03996)**

(Hong Kong – 9 Dec 2015) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of CHINA ENERGY ENGINEERING CORPORATION LIMITED (“CH ENERGY ENG”; stock code: 03996) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for CH ENERGY ENG on PhillipMart were HK\$1.57 and HK\$1.50. The price closed at HK\$1.57 per share, 1.26% lower than its offer price of HK\$1.59. The price opened at HK\$1.50, with the most actively traded price of HK\$1.53 per share, and a turnover of 1,128,000 shares. The total trading volume reached 1,370,000 shares with **total turnover of HK\$2,095,380.00**. The final price of CH ENERGY ENG, to debut trading tomorrow has been fixed at HK\$1.59 per share.
