

## PhillipMart Announces Pre-IPO Share Price of CHUANGMEI PHARMACEUTICAL CO., LTD (Stock code: 02289)

(Hong Kong – 11 Dec 2015) Phillip Securities (HK) Ltd. ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of CHUANGMEI PHARMACEUTICAL CO., LTD ("CHUANGMEI PHARMACEUTICAL"; stock code: 02289) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for CHUANGMEI PHARMACEUTICAL on PhillipMart were HK\$8.80 and HK\$8.56. The price closed at HK\$8.56 per share,0.47% lower than its offer price of HK\$8.60.
