

PhillipMart Announces Pre-IPO Share Price of Modern Dentral Group Limited (Stock code: 03600)

(Hong Kong – 14 Dec 2015) Phillip Securities (HK) Ltd. ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of Modern Dentral Group Limited ("Modern Dentral Group Limited"; stock code: 03600) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Modern Dentral on PhillipMart were HK\$4.10 and HK\$4.00. The price closed at HK\$4.04 per share,3.81% lower than its offer price of HK\$\$4.20. The price opened at HK\$4.10, with the most actively traded price of HK\$4.00 per share, and a turnover of 147,000shares. The total trading volume reached 340,000shares with **total turnover of HK\$1,375,250.00**. The final price of Modern Dentral, to debut trading tomorrow has been fixed at HK\$4.20 per share.
