

**PhillipMart Announces Pre-IPO Share Price of  
 CRCC High-Tech Equipment Corp. Ltd (Stock code: 01786)**

(Hong Kong – 15 Dec 2015) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of CRCC High-Tech Equipment Corp. Ltd (“CRCC”; stock code: 01786) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for CRCC on PhillipMart were HK\$5.20 and HK\$5.00. The price closed at HK\$5.20 per share, 0.95% lower than its offer price of HK\$5.25. The price opened at HK\$5.00, with the most actively traded price of HK\$5.02 per share, and a turnover of 20,500 shares. The total trading volume reached 75,500 shares with **total turnover of HK\$382,360.00**. The final price of CRCC, to debut trading tomorrow has been fixed at HK\$5.25 per share.
