PhillipMart Announces Pre-IPO Share Price of Yee Hop Holdings Limited (Stock code: 01662)

(Hong Kong – 17 Dec 2015) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of Yee Hop Holdings Limited ("Yee Hop"; stock code: 01662) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Yee Hop on PhillipMart were HK\$1.06and HK\$0.93. The price closed at HK\$1.03 per share,3% higher than its offer price of HK\$\$1.00. The price opened at HK\$1.00, with the most actively traded price of HK\$1.02 per share, and a turnover of 896,000shares. The total trading volume reached 2,156,000shares with **total turnover of HK\$2,202,160.00**. The final price of Yee Hop, to debut trading tomorrow has been fixed at HK\$1.00 per share.
