## PhillipMart Announces Pre-IPO Share Price of China Hengshi Foundation Company Limited (Stock code: 01197)

(Hong Kong – 18 Dec 2015) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of CHINA HENGSHI FOUNDATION COMPANY LIMITED ("CHINA HENGSHI"; stock code: 01197) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for CHINA HENGSHI on PhillipMart were HK\$2.35 and HK\$2.29. The price closed at HK\$2.35 per share,9.3% higher than its offer price of HK\$\$2.15. The price opened at HK\$2.33, with the most actively traded price of HK\$2.29per share, and a turnover of 16,000shares.
