

**PhillipMart Announces Pre-IPO Share Price of
 Bank of Zhengzhou Co., Ltd. (Stock code: 06196)**

(Hong Kong – 22 Dec 2015) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of Bank of Zhengzhou Co., Ltd. (“Bank of Zhengzhou”; stock code: 06196) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Bank of Zhengzhou on PhillipMart were HK\$3.76 and HK\$3.72. The price closed at HK\$3.75 per share, 2.59% lower than its offer price of HK\$3.85. The price opened at HK\$3.72, with the most actively traded price of HK\$3.75 per share, and a turnover of 16,000 shares. The total trading volume reached 24,000 shares with **total turnover of HK\$90,000**. The final price of Bank of Zhengzhou, to debut trading tomorrow has been fixed at HK\$3.85 per share.
