

**PhillipMart Announces Pre-IPO Share Price of  
 SUNDART HOLDINGS LIMITED (Stock code: 01568)**

(Hong Kong – 28 Dec 2015 ) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of SUNDART HOLDINGS LIMITED (“SUNDART HLDGS”; stock code: 01568) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for SUNDART HLDGS on PhillipMart were HK\$1.49 and HK\$1.39. The price closed at HK\$1.46 per share, 5.08% Higher than its offer price of HK\$1.38. The price opened at HK\$1.43, with the most actively traded price of HK\$1.45 per share, and a turnover of 2,362,000 shares. The total trading volume reached 4,630,000 shares with **total turnover of HK\$6,667,460.00**. The final price of SUNDART HLDGS, to debut trading tomorrow has been fixed at HK\$1.38 per share.
