

PhillipMart Announces Pre-IPO Share Price of Genscript Biotech Corporation (Stock code: 01548)

(Hong Kong – 29 Dec 2015) **Phillip Securities** (**HK**) **Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of Genscript Biotech Corporation ("Genscript Biotech"; stock code: 01548) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Genscript Biotech on PhillipMart were HK\$1.42 and HK\$1.38. The price closed at HK\$1.42 per share, 8.4% higher than its offer price of HK\$1.31. The price opened at HK\$1.38, with the most actively traded price of HK\$1.42 per share, and a turnover of 536,000shares. The total trading volume reached 1,012,000shares with **total turnover of HK\$1,426,820.00**. The final price of Genscript Biotech, to debut trading tomorrow has been fixed at HK\$1.31 per share.
