

**PhillipMart Announces Pre-IPO Share Price of
 Holly Futures (Stock code: 03678)**

(Hong Kong – 29 Dec 2015) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of Holly Futures (stock code: 03678) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Holly Futures on PhillipMart were HK\$2.57 and HK\$2.55. The price closed at HK\$2.55 per share, 4.94% higher than its offer price of HK\$2.43.
