

**PhillipMart Announces Pre-IPO Share Price of
 PERFECT GROUP INTERNATIONAL HOLDINGS LIMITED (Stock code: 03326)**

(Hong Kong – 31 Dec 2015) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of PERFECT GROUP INTERNATIONAL HOLDINGS LIMITED (“PERFECT GROUP”; stock code: 03326) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for PERFECT GROUP on PhillipMart were HK\$1.25 and HK\$1.10. The price closed at HK\$1.15 per share, 23.66% higher than its offer price of HK\$0.93. The price opened at HK\$1.10, with the most actively traded price of HK\$1.16 per share, and a turnover of 648,000 shares. The total trading volume reached 648,000shares with **total turnover of HK\$762,030.00**. The final price of PERFECT GROUP, to debut trading on 4 Jan 2016 and it has been fixed at HK\$0.93 per share.
