

**PhillipMart Announces Pre-IPO Share Price of  
 NNK Group Limited (Stock code: 03773)**

(Hong Kong – 6 Jan 2016 ) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of NNK Group Limited (“NNK Group Limited”); stock code: 03773) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for NNK Group Limited on PhillipMart were HK\$1.3 and HK\$1.05. The price closed at HK\$1.17 per share, 17% higher than its offer price of HK\$1.00. The price opened at HK\$1.05, with the most actively traded price of HK\$1.17 per share, and a turnover of 952,000shares. The total trading volume reached 6,808,000shares with **total turnover of HK\$8,119,620.00**. The final price of NNK Group Limited, to debut trading tomorrow has been fixed at HK\$1.00 per share.
