

## PhillipMart Announces Pre-IPO Share Price of Jujiang Construction Group Co., Ltd (Stock code: 01459)

(Hong Kong – 11Jan 2016) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of Jujiang Construction Group Co., Ltd ("Jujiang Construction"; stock code: 01459) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Jujiang Construction on PhillipMart were HK\$1.49 and HK\$1.30. The price closed at HK\$1.46 per share, 8.15% higher than its offer price of HK\$1.35. The price opened at HK\$1.30, with the most actively traded price of HK\$1.37 per share, and a turnover of 428,000shares. The total trading volume reached 1,704,000shares with **total turnover of \$2,428,880.00**. The final price of Jujiang Construction, to debut trading tomorrow has been fixed at HK\$1.35 per share.
