

PhillipMart Announces Pre-IPO Share Price of Ronshine China Holdings Limited (Stock code: 03301)

(Hong Kong – 12 Jan 2016) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of Ronshine China Holdings Limited ("Ronshine China"; stock code: 03301) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Ronshine China on PhillipMart were HK\$5.30 and HK\$5.18. The price closed at HK\$5.30 per share, 1.12% lower than its offer price of HK\$5.36. The price opened at HK\$5.18, with the most actively traded price of HK\$5.18 per share, and a turnover of 74,500shares. The total trading volume reached 78,500shares with **total turnover of \$407,110.00**. The final price of Ronshine China, to debut trading tomorrow has been fixed at HK\$5.36 per share.
