## **PhillipMart Announces Pre-IPO Share Price of** Virscend Education Company Limited (Stock code: 1565)

(Hong Kong – 14 Jan 2016) Phillip Securities (HK) Ltd. ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of Virscend Education Company Limited ("Virscend Edu"; stock code: 1565) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Virscend Edu on PhillipMart were HK\$2.55 and HK\$2.4. The price closed at HK\$2.5 per share, 4.17% higher than its offer price of HK\$2.4. The price opened at HK\$2.4, with the most actively traded price of HK\$2.5 per share, and a turnover of 209,000 shares. The total trading volume reached 484,000 shares with total turnover of HK\$ 1,203,500. The final price of Virscend Edu, to debut trading tomorrow has been fixed at HK\$2.4 per share.
