

## PhillipMart Announces Pre-IPO Share Price of China Rongzhong Financial Holdings Company Limited (Stock code: 03963)

(Hong Kong – 27Jan 2016) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of China Rongzhong Financial Holdings Company Limited ("Rongzhong Financial"; stock code: 03963) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Rongzhong Financial on PhillipMart were HK\$2.30 and HK\$2.15. The price closed at HK\$2.28 per share, 8.06% higher than its offer price of HK\$2.11. The price opened at HK\$2.15, with the most actively traded price of HK\$2.20 per share, and a turnover of 511,000 shares. The total trading volume reached 2,428,000shares with **total turnover of \$5,377,580.00**. The final price of Rongzhong Financial, to debut trading tomorrow has been fixed at HK\$2.11 per share.
