

**PhillipMart Announces Pre-IPO Share Price of
 Sinco Pharmaceuticals Holdings Limited (Stock code: 06833)**

(Hong Kong – 9 Mar 2016) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of Sinco Pharmaceuticals Holdings Limited (“Sinco Pharma”; stock code: 06833) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Sinco Pharma on PhillipMart were HK\$0.95 and HK\$0.86. The price closed at HK\$0.91 per share, 13.75% higher than its offer price of HK\$0.8. The price opened at HK\$0.88, with the most actively traded price of HK\$0.91 per share, and a turnover of 2,300,000 shares. The total trading volume reached 5,312,000shares with **total turnover of \$4,786,640.00**. The final price of Sinco Pharma, to debut trading tomorrow has been fixed at HK\$0.8 per share.
