

**PhillipMart Announces Pre-IPO Share Price of
 Union Medical Healthcare Limited (Stock code: 02138)**

(Hong Kong – 10 Mar 2016) Phillip Securities (HK) Ltd. (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of Union Medical Healthcare Limited (“Union Medical”; stock code: 02138) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Union Medical on PhillipMart were HK\$3.30 and HK\$3.10. The price closed at HK\$3.30 per share, 8.91% higher than its offer price of HK\$3.03. The price opened at HK\$3.10, with the most actively traded price of HK\$3.30 per share, and a turnover of 49,000 shares. The total trading volume reached 165,000 shares with **total turnover of \$532,300.00**. The final price of Union Medical, to debut trading tomorrow has been fixed at HK\$3.03 per share.
