

PhillipMart Announces Pre-IPO Share Price of K. H. Group Holdings Limited (Stock code: 01557)

(Hong Kong – 17 March 2016) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of K. H. Group Holdings Limited ("K. H. Group"; stock code: 01557) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for K. H. Group on PhillipMart were HK\$1.23 and HK\$1.10. The price closed at HK\$1.17 per share, 23.16% higher than its offer price of HK\$0.95. The price opened at HK\$1.10, with the most actively traded price of HK\$1.15 per share, and a turnover of 2,672,000shares. The total trading volume reached 8,592,000shares with **total turnover of \$9,997,440.00**. The final price of K. H. Group, to debut trading tomorrow has been fixed at HK\$0.95 per share.
