

PhillipMart Announces Pre-IPO Share Price of Bank of TianJin Co., Ltd. (Stock code: 01578)

(Hong Kong – 29 Mar 2016) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of Bank of TianJin Co., Ltd. ("Bank of TianJin"; stock code: 01578) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Bank of TianJin on PhillipMart were HK\$7.47 and HK\$7.23. The price closed at HK\$7.47 per share, 1.08% higher than its offer price of HK\$7.39. The price opened at HK\$7.23, with the most actively traded price of HK\$7.45 per share, and a turnover of 7,000 shares. The total trading volume reached 20,500shares with **total turnover of HK\$151,435.00**. The final price of Bank of TianJin, to debut trading tomorrow has been fixed at HK\$7.39 per share.
