

## PhillipMart Announces Pre-IPO Share Price of SMIT HOLDINGS LIMITED (Stock code: 02239)

(Hong Kong – 29 Mar 2016) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of SMIT HOLDINGS LIMITED ("SMIT"; stock code: 02239) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for SMIT on PhillipMart were HK\$4.00 and HK\$3.39. The price closed at HK\$3.39 per share, 10.32% lower than its offer price of HK\$3.78. The price opened at HK\$4.00, with the most actively traded price of HK\$3.50 per share, and a turnover of 131,000 shares. The total trading volume reached 657,000shares with **total turnover of HK\$2,386,340.00**. The final price of SMIT, to debut trading tomorrow has been fixed at HK\$3.78 per share.
