

PhillipMart Announces Pre-IPO Share Price of Get Nice Financial Group Limited (Stock code: 01469)

(Hong Kong – 7 April 2016) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of Get Nice Financial Group Limited ("Get Nice Financial"; stock code: 01469) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Get Nice Financial on PhillipMart were HK\$1.05 and HK\$1.00. The price closed at HK\$1.04 per share, 4% higher than its offer price of HK\$1.00. The price opened at HK\$1.00, with the most actively traded price of HK\$1.05 per share, and a turnover of 648,000shares. The total trading volume reached 1,164,000shares with **total turnover of HK\$1,215,160.00**. The final price of Get Nice Financial, to debut trading tomorrow has been fixed at HK\$1.00 per share.
