

PhillipMart Announces Pre-IPO Share Price of AP RENTALS HOLDINGS LIMITED (Stock code: 01496)

(Hong Kong – 7 April 2016) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of AP RENTALS HOLDINGS LIMITED ("AP RENTALS"; stock code: 01496) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for AP RENTALS on PhillipMart were HK\$1.16 and HK\$0.9. The price closed at HK\$1.15 per share, 53.33% higher than its offer price of HK\$0.75. The price opened at HK\$0.9, with the most actively traded price of HK\$1.00 per share, and a turnover of 2,604,000shares. The total trading volume reached 20,000,000shares with **total turnover of HK\$21,424,000.00**. The final price of AP RENTALS, to debut trading tomorrow has been fixed at HK\$0.75 per share.
