PhillipMart Announces Pre-IPO Share Price of Wang On Properties Limited (Stock code: 01243)

(Hong Kong – 11 April 2016) Phillip Securities (HK) Ltd. ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of Wang On Properties Limited ("Wang On PPT"; stock code: 01243) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Wang On PPT on PhillipMart were HK\$0.96 and HK\$0.92. The price closed at HK\$0.94 per share, 2.17% higher than its offer price of HK\$0.92. The price opened at HK\$0.93, with the most actively traded price of HK\$0.95 per share, and a turnover of 1,024,000 shares. The total trading volume reached 1,372,000shares with total turnover of HK\$1,301,520.00 The final price of Wang On PPT, to debut trading tomorrow has been fixed at HK\$0.92 per share.
