

**PhillipMart Announces Pre-IPO Share Price of
 Nameson Holdings Limited (Stock code: 01982)**

(Hong Kong – 11 April 2016) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of Nameson Holdings Limited (“Nameson Holdings”; stock code: 01982) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Nameson Holdings on PhillipMart were HK\$1.33 and HK\$1.24. The price closed at HK\$1.33 per share, 10.83% higher than its offer price of HK\$1.20. The price opened at HK\$1.24, with the most actively traded price of HK\$1.30 per share, and a turnover of 1,580,000 shares. The total trading volume reached 5,636,000 shares with **total turnover of HK\$7,251,320.00**. The final price of Nameson Holdings, to debut trading tomorrow has been fixed at HK\$1.20 per share.
