

PhillipMart Announces Pre-IPO Share Price of Yadea Group Holdings Limited (Stock code: 01585)

(Hong Kong – 18 May 2016) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of Yadea Group Holdings Limited ("Yadea"; stock code: 01585) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Yadea on PhillipMart were HK\$1.66 and HK\$1.55. The price closed at HK\$1.63 per share, 5.23% lower than its offer price of HK\$1.72. The price opened at 1.62, with the most actively traded price of HK\$1.63 per share, and a turnover of 150,000 shares. The total trading volume reached 824,000shares with **total turnover of HK\$1,323,900.00**. The final price of Yadea, to debut trading tomorrow has been fixed at HK\$1.72 per share.
