

## PhillipMart Announces Pre-IPO Share Price of BOC Aviation Limited (Stock code: 02588)

(Hong Kong – 31 May 2016) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of BOC Aviation Limited ("BOC Aviation"; stock code: 02588) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for BOC Aviation on PhillipMart were HK\$45.2 and HK\$43.9. The price closed at HK\$44 per share, 4.76% higher than its offer price of HK\$42. The price opened at HK\$45, with the most actively traded price of HK\$44 per share, and a turnover of 461,600 shares. The total trading volume reached 2,268,700shares with **total turnover of HK\$100,446,850**. The final price of BOC Aviation, to debut trading tomorrow has been fixed at HK\$42 per share.
