

PhillipMart Announces Pre-IPO Share Price of Chuan Holdings (Stock code: 01420)

(Hong Kong – 7Jun 2016) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of Chuan Holdings ("Chuan Holdings"; stock code: 01420) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Chuan Holdings on PhillipMart were HK\$1.04 and HK\$0.73. The price closed at HK\$0.74 per share, 15.91% lower than its offer price of HK\$0.88. The price opened at HK\$1, with the most actively traded price of HK\$0.75 per share, and a turnover of 3,816,000shares. The total trading volume reached 19,064,000shares with **total turnover of HK\$15,472,76.00**. The final price of Chuan Holdings, to debut trading tomorrow has been fixed at HK\$0.88 per share.
