

PhillipMart Announces Pre-IPO Share Price of iBond 2016 (Stock code: 04231)

(Hong Kong – 20 Jun 2016) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of iBond 2016 ("iBond 6"; stock code: 04231) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for iBond 6 on PhillipMart were HK\$104.85 and HK\$104. The price closed at HK\$104.75 per share, 4.75% higher than its offer price of HK\$100. The price opened at HK\$104.2, with the most actively traded price of HK\$104.8 per share, and a turnover of 831,500 shares. The total trading volume reached 1,467,100 shares with **total turnover of HK\$153,691,270.00**. The final price of iBond 6, to debut trading tomorrow has been fixed at HK\$100 per share.
