## PhillipMart Announces Pre-IPO Share Price of China Digital Video Holdings Limited (Stock code: 08280)

(Hong Kong – 24 June 2016) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **China Digital Video Holdings Limited ("CDV Holdings"; stock code: 08280)** on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for **CDV Holdings** on PhillipMart were HK\$2.33 and HK\$2.00. The price closed at HK\$2.23 per share,17.37% higher than its offer price of HK\$\$1.90. The price opened at HK\$2.00, with the most actively traded price of HK\$2.20 per share, and a turnover of 100,000shares. The total trading volume reached 536,000shares with **total turnover of HK\$1,137,360.00**. The final price of **CDV Holdings**, to debut trading tomorrow has been fixed at HK\$1.90per share.
