

**PhillipMart Announces Pre-IPO Share Price of
 Ever Harvest Group Holdings Limited (Stock code: 01549)**

(Hong Kong – 5 Jul 2016) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of Ever Harvest Group Holdings Limited (“Ever Harvest Group”; stock code: 01549) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Ever Harvest Group on PhillipMart were HK\$0.365 and HK\$0.34. The price closed at HK\$0.365 per share, 15.87% higher than its offer price of HK\$0.315. The price opened at HK\$0.365, with the most actively traded price of HK\$0.355 per share, and a turnover of 7,808,000 shares. The total trading volume reached 27,304,000shares with **total turnover of HK\$9,682,080.00**. The final price of Ever Harvest Group, to debut trading tomorrow has been fixed at HK\$0.315 per share.
