

**PhillipMart Announces Pre-IPO Share Price of
 DFZQ-H shares (Stock code: 03958)**

(Hong Kong – 7 Jul 2016) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of DFZQ-H shares (Stock code: 03958) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for DFZQ on PhillipMart were HK\$8.21 and HK\$8.05. The price closed at HK\$8.10 per share, 0.613% lower than its offer price of HK\$8.15. The price opened at HK\$8.20, with the most actively traded price of HK\$8.10 per share, and a turnover of 63,200 shares. The total trading volume reached 106,000 shares with **total turnover of HK\$806,800.00**. The final price of DFZQ, to debut trading tomorrow has been fixed at HK\$8.15 per share.
