

PhillipMart Announces Pre-IPO Share Price of XinYi Automobile Glass Hong Kong Enterprises Limited (Stock code: 08328)

(Hong Kong – 8 Jul 2016) **Phillip Securities** (**HK**) **Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of XinYi Automobile Glass Hong Kong Enterprises Limited ("XinYi HK"; stock code: 08328) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for XinYi HK on PhillipMart were HK\$1.2 and HK\$0.72. The price closed at HK\$1.19 per share, 70% higher than its offer price of HK\$0.7. The price opened at HK\$0.74, with the most actively traded price of HK\$1.00 per share, and a turnover of 1,148,000 shares. The total trading volume reached 6,252,000 shares with **total turnover of HK\$5,761,080.00**. The final price of XinYi HK, to debut trading on 8 Jul has been fixed at HK\$0.7 per share.
