

**PhillipMart Announces Pre-IPO Share Price of  
 CHINA LEON INSPECTION HOLDING LIMITED (Stock code: 1586)**

(Hong Kong – 11 Jul 2016 ) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of CHINA LEON INSPECTION HOLDING LIMITED (“CHINA LEON”; stock code: 1586) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for CHINA LEON on PhillipMart were HK\$1.19 and HK\$1.06. The price closed at HK\$1.15 per share, 17.35% Higher than its offer price of HK\$0.98. The price opened at HK\$1.06, with the most actively traded price of HK\$1.17 per share, and a turnover of 740,000 shares. The total trading volume reached 2,732,000 shares with **total turnover of 3,171,520**. The final price of CHINA LEON, to debut trading tomorrow has been fixed at HK\$0.98 per share.
